NOW KNOW all men by these Presents that I Paul Ruiz of Ann Arundell County in the Province of Maryland Merchant for & in Consideration that as well the said William Cumming Michael Macromara & Samuel Soumaine became Sureties for me the said Paul Ruiz my Personal Appearance at the Provincial Court a^d as well for their Indemnification from all Costs & Charges whatsoever accruing on their the said William Cumming Michael Macromara & Samuel Soumaine becoming Sureties for me the said Paul Ruiz as for the Sum of five Shillings Sterling Money to me in hand paid before Sealing & Delivery hereof I the said Paul Ruiz Have by these Presents Bargained & Sold unto the said William Cumming Michael Macromara & Samuel Soumaine the a^d six Negroes named Peter, Moll, Peter, Charles, Golah Jack, & Sarah and also two other Negro Men carpenters by Trade purchased by me the said Paul Ruiz of a certain Tailor Higgenon Attorney in fact of John Tailor Merchant in LONDON aforesaid & one other Negroe (Woman)
