Charles Carroll his Heirs Execs & Assigns by these presents, That the said
Abraham Garrett hath given Granted Bargained sold alienated Enfeoffed and Conveyed
and by these presents doth give Grant Bargain sell alien Enfeoff and Convey unto
the said Charles Carroll his Heirs and Assigns all that part and parcel of Land
hereofore bequeathed unto a certain William Wright by his father Blows Wright
late of Baltimore County Deed Supposed to contain One Hundred & fifty acres of Land
to the same more or less lying in the County aforesaid at the Mouth and on the South side
of Gunpowder River with said Land the aforesaid William Wright did by his Testa-
ment of Bargain and Sale bearing Date on the first Day of September in the Year
of Our Lord One Thousand Seven Hundred and Forty One, give Grant Bargain
sell and Convey unto the said Abraham Garrett his Heirs and Assigns for Ever All also
all the Right, Title, Claim, Interest, Property and Demand what ever the said
William Wright had or Ever hereafter might have of in and to all or any
lands bequeathed by the aforesaid Blows Wright unto his son Thomas Wright and
his Heirs as by the said Owners Last Will and Testament may appear to the same
more or less. Within said Land and promises and Every part and parcel thereof the
said Abraham Garrett has by these presents sold Conveyed and made over unto him the
said Charles Carroll his Heirs and Assigns for Ever together with all Rights profits
