This Indenture made the Nineteenth Day of July Anno Domini  
One thousand Seven hundred thirty Eight Between Michael Taylor of Prince  
Georges County Gentleman & Margaret his Wife on the one Part & Charles  
Carroll of the City of Annapolis Physician on the other Part witnesseth  
that Whereas Michael Taylor by his Indented Deed of Bargain & Sale  
bearing date the Thirtieth Day of June Anno Domini One thousand  
Seven hundred & thirty duly Executed Acknowledged & Recorded did  
among Other things wherein Bargain sold unto his said wife  
over unto him the said Charles Carroll two Tracts or Parcels of  
Land Situate lying & being in Prince Georges County near the Eastern  
Branch of Potowmack River being the Dwelling Plantation of him  
the said Michl. Taylor one of which Tracts of Land called Barbadoes  
containing two hundred & fifty Acres of Land the other containing two  
hundred Acres being part of a tract of Land called Scotland consisting in  
all of four hundred & fifty Acres of Land as by the said Deed aforesaid  
being thereto had may more at Large appear And Whereas the  
said Michl. Taylor since the Execution of Delivery of the said Deed  
hath made a Survey or Surveyor on his said Dwelling Plantation  
& between the said Tracts of Land called Barbadoes & Scotland by  
Means wherof the said Tracts of Land may become Disjoined &  
the said Dwelling Plantation & Right of Property thereto becoming  
Procurious Disputable & uncertain to him the said Charles Carroll his  
heirs & Assigns contrary to the just & true Intent & meaning of the said  
noted Deed & Whereas further that he the said Michael Taylor &  
Margaret his Wife did by their Indented Deed of Bargain & Sale bearing  
Date the Eleventh Day of September Anno Domini One thousand  
Seven hundred thirty four for the Considerations therein Express'd  
as further Security to him the said Charles Carroll for the sum of  
two hundred & fifty two Pounds Sterling money of Great Britain  
to them the said Michael Taylor & Margaret his wife by the said  
Charles paid & satisfied A sum of Two Pounds Sterling money of Great Britain  
made over unto him the said Charles Carroll all his Estate Right  
Title Interest claim & Demand of him the said Michael & Margaret  
his wife & in & to a Tract of Land Situate & lying in Prince Georges  
County called Addition to Harley Forest that is to say all that  
part of the said Land bounded by Robert & John Bradford to foie his  
wife & by the said foie to Margaret the now wife of the said Michael  
Containing twelve hundred & Seventy Acres of Land with all  
& Singular its Accurances as by the said Deed may appear.
