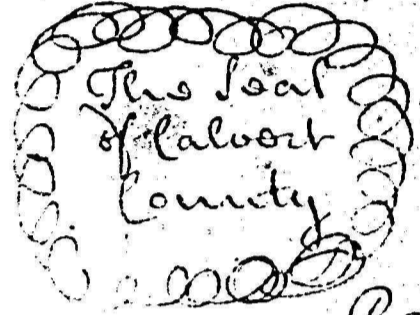

This Indenture made the twenty fourth Day of February in the Year of our  
 Lord Seventeen hundred and thirty eight Between Arisah Woodward of the  
 City of Annapolis Widow of the one part and Calob Dorsey of the same  
 County Gentleman of the other part Witnesses that the said Arisah Woodward  
 for and in Consideration of the natural Love & Affection which she hath & doth  
 bear to her Children Mary Elizabeth & Hannah Woodward & for their better  
 Support & Maintenance & for in Consideration of five Shillings to her in  
 hand paid by the said Calob Dorsey the Receipt whereof is hereby acknowledged  
 hath given granted & confirmed and by these presents give grant & confirm  
 unto the said Calob Dorsey to his Heirs hereafter mentioned all and singular  
 her Goods Chattels Debt ready Money Plate Rings household stuff Utens-  
 ills Bras Bowls Copper Bedding Meat Cattle Horses Sheep Hogs and all  
 other her Substances of every kind & Quality movable & immovable Lish  
 & Dead of what kind quality Nature or Condition soever as they now are  
 or which at any time hereafter during the Continuance of the said Arisah  
 sole & unmarried they shall or may be improved or increased to have  
 and to hold all and singular the said Goods Chattels Money Debt and all  
 other the Promises to the said Calob Dorsey to his only proper use and  
 behoof
