 hereof made for preservation at Dumbarton fourth Day of December
 One thousand Seven hundred and thirty eight years and of the
 Reigne of our Sovereign Lord George the Second King of Great

July 14th 1739 before us the Subscribers two of the Right Honourable the Lord
 Bishops Justices of the Peace for the County of Somerset James Robert
 Boyd one of the Subscribing Witnesses and made Oath on the Holy
 Evangelis of Almighty God that on the fourth Day of December last
 at the City of Dumbarton in that part of Great Britain called
 Scotland he saw W. William Campbell of the same place sign Seal
 Execute and Deliver the within power of Attorney as his Act and Deed
 that at the same time he saw Charles Kirkpatrick sign the same as
 an Evidence in Testimony whereof we have herunto set our hands this
 Day & Year above written
