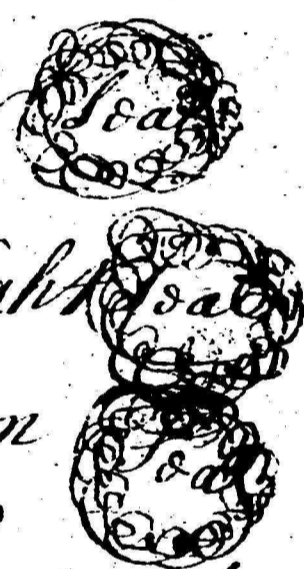


Same Recovery & Recoverys & all Recoverys Settlements
