




This Indenture made this Twenty third of March in the Year of our Lord Seventeen hundred and fifty Between George Parker of Charles County Gentleman of the one part and his Excellency Samuel Ogle Esq. of the other part Whereas the said George Parker together with Richard Cole and William Cole by his Bond or Obligation duly executed bearing date the twentieth Day of February in the Year of our Lord Seventeen hundred and fifty stands bound to the said Samuel Ogle in the sum of five hundred Pounds Sterling Conditioned for the Payment of the sum of two hundred and fifty Pounds Sterling with legal Interest for the same at or upon the first Day of February next ensuing the Date of the said Bond or Obligation Now this Indenture Witnesseth that the said George Parker in Consideration of the said Debt or sum of two hundred and fifty Pounds Sterling and for the better securing the Payment thereof with Interest to the said Samuel Ogle his Executors Administrators or Assigns according to the Condition of the said Bond and also in consideration of the further sum of five Shillings to him the said George Parker by the said Samuel Ogle at or before the Sealing and Delivery of these Presents likewise well and truly paid the receipt whereof is hereby acknowledged Hath granted Bargained
