widow named Arthur Lee and Charles Jones Gentleman and Lawyer by profession did make instrument of writing to be their att -
and attest that at the same time then the wife of the said Arthur Lee and Elizabeth the wife of the said Charles Jones severally relinquished
their right of power of in and unto their lands herein mentioned according as the parts hereof are limited and assigned and bearing also by me -
severally examined apart from each other of their said husbands declared that they did the same voluntarily and freely - -
without being induced thereto by fear of ill usage from their husbands aforesaid or any threat of fine & imprisonment
