 in my name or his own name as my Assignee to Ask Demand sue for Levy Recover and
 Receive of and from the said Samuel Howard his Heirs Executors or Adm^r the Principal Money
 and Interest now due or which shall hereafter arise due on the said two Judgments together
 with the costs of Suit in them severally mentioned and the same Money and Tobacco when
