


175.) On the fifteenth Day of April in the Year of our Lord One Thousand Seven hundred and fifty one
Before me William Sudman Notary and Tabellion Publick Dwelling in London duly Admitted and
Sworn and Witneses Personally appeared Mss^rs Jonathan Sydenham & Thomas Hodgson of
London Merchants Who declared to have made Ordained Constituted authorized and appointed
and by these Presents Do make Ordain Constitute Authorize and Appoint William Rue of the
Province of Maryland Merchant their True and Lawfull Attorney Giving and hereby Granting
unto their said Attorney full Power and Lawfull Authority for them the said Constituents to
in their Names and for their Use to Aft Demand Levy Suer for and by all Lawfull ways and
means recover and receive of and from all and every or any Person or Persons whatsoever —
whom it shall or may concern Inhabiting or being in the Province of Maryland aforesaid
all such sum and sums of Money Goods Wares Merchandise Effects Estate and Things —
which now are or shall or may hereafter be due owing Payable belonging or in anywise
appertaining unto them the said Constituents whether by Bond Note Bill Book Debt

for by or upon any other Account way reason or means soever nothing in Law or Equity
Excepted or Reserved And to that end with all and every or any Person or Persons concerned
to Account and to View State Settle and Adjust all Accounts and the Balance thereof to receive
And upon Recovery and Receipts to give one or more Acquittances or other sufficient discharges
in due form of Law But in case of refusal or delay by all and every or any Person or Persons —
whatsoever whom it shall or may concern to make and under just and true Account Payment
Delivery and Satisfaction in the Premises him her them any or either of them hereunto to —
Compel by all Lawfull ways and means whatsoever Also (if need be) to appear before all or
any Judges and Justices in any Court or Courts there to Answer Defend and Reply in all
matters and causes touching or concerning the Premises to do say pursue Implead Seize
Sequester Attach Arrest Imprison and to Condemn and out of Prison again to deliver
Also to compound Conclude and Agree by Arbitration or otherwise as their said Attorney
shall think fit And Generally in and concerning the Premises to do perform and execute
all of whatsoever shall be requisite and necessary as fully amply and effectually to all

Personally Present With Power to Substitute one or more Attorneys under him with like
or limited Power and the same again to revoke They the said Jonathan Sydenham and
Thomas Hodgson hereby ratifying confirming and holding for good and valid all and
whatsoever the said William Rue or his Substitutes shall Lawfully do or cause to be done
