fully absolutely and Truly Give Grant Bargain Sell Alien Enfeoff and Confirm unto him the
said Charles Canoll all that part of a Tract of Land called Edward of Will's Valies of Mills
in Baltimore County which was Convoied to him the said Richard by his Brother Edward
Stevenson the second Day of March One Thousand Seven hundred thirty and five (containing
two hundred and ninety Acres of Land being the Dwelling Plantation of him the said
Richard King Stevenson as also all that Tract or parcel of Land called Good Will
