Plumer Iams doth hereby acknowledge and thereof from any part and parcel thereof doth for himself  
his Heirs Ex<sup>r</sup> & Adm<sup>r</sup> or Assigns for ever acquit Exonorate and Discharge the said Lewis Griffith his  
Heirs Ex<sup>r</sup> & Adm<sup>r</sup> by these Presents hath given granted Bargained Sold aliened Enfeoffed and  
Confirmed and by these Presents doth give grant Bargain sell Alien Enfeoff and Confirm unto him  
the said Lewis Griffith his Heirs and Assigns for ever part of two Tracts of Land situate Lymig and  
being in Lyons Creek Hundred in Salvoit County aforesaid on the East side of Patuxent River  
and on the said River called Archers Hays by the following Metes and Bounds that is to say —  
Beginning at Patuxent River Side where the Land late Burden Crosby's Second line of the said  
Land ends, and running with the line of the said Land North fifty three Degrees East One hundred  
and fifteen Paces to the said Crosby's bounded line then running West with the Original line  
of the said Tract of Land called Archers Hays two hundred and twenty Paces then running South  
still with another of the Original lines to the Land of Samuel Griffith aforesaid then running West  
with the said Griffiths Land two hundred and seventeen Paces thence running a few Paces to  
the Branch that lies to the Northward of the plantation where William Bent lately Dwelt then

of these Presents hath good right and lawfull Power and authority to Sell and Convey the before

the same is free and clear from all Incumbrances whatsoever and that from time to time and at all

to have hold and Occupy Quietly and Peaceably Expect and Enjoy the before mentioned Bargained Land and  
Premises with their Appurtenances without any hindrance or molestation of him the said Plumer  
Iams his Heirs Ex<sup>r</sup> & Adm<sup>r</sup> or any other Person or Persons by his or their Procurement and that  
he the said Plumer Iams the same Lands and Premises with their Appurtenances against the Lawfull  
Claim of him the said Plumer Iams his Heirs Executors and Adm<sup>r</sup> or any other Person or Persons  
claiming or pretending to claim from by or under him them or any of them and against the Lawfull  
Claim of all Persons whatsoever to him the said Lewis Griffith his Heirs and Assigns shall and will  
for ever warrant and Defend by these Presents And Lastly that he the said Plumer Iams his
