To the Honourable Justice Robert Ogden Greeting Know Ye that I the said Frederick Lord Baltimore and the said Arthur Onslow and John Sharpe Guardians of the said Lord Baltimore on his behalf by Virtue of the Powers in the Letters Patent from King Charles the first to the said Baron of Baltimore his Heirs and Assignes of the said Province of Maryland &c. Do by these Presents Enstablish you the said Justice Ogden to Exercise the Office of Secretary of the said Province of Maryland during our Pleasure hereby Authorizing you and giving you full Power to Nominate and Appoint a sufficient Deputy And also Authorizing and Imposing you or your sufficient Deputy to be present at all meetings of the Governor and Council and of the Assembly in that Province and keep an exact Register of all their Acts Proceedings and Orders and to do and perform all other Acts usually done by the former Secretaries of (Province)
