This Indenture made this fifteenth Day of April in the Year of our Lord One Thousand Seven hundred and fifty two Between Richard Snowden of Annapolis County Iron Master on the one part and Charles Carroll of the City of Annapolis Surgeon on the other part Witnesseth That the said Richard Snowden for and in Consideration of the Sum of Twenty Pounds Sterling Money of Great Britain to him in hand paid by him the said Charles Carroll the receipt whereof he doth hereby acknowledge Hath given granted Bargained Sold Alienated Enfeoffed and Confirmed and by these Presents Doth give grant Bargain Sell Alien Enfeoff and Confirm unto him the said Charles Carroll his Heirs and Assigns for ever All that Tract of Land called Walnut Level granted to him the said Richard Snowden the fourteenth Day of December in the Year of our Lord God One Thousand Seven hundred and thirty nine Situate and being in Frederick County Beginning at a Bounded Stickony standing on a Hill side between Antietam and the Mountains and running thence North forty six Perches then East One hundred and twenty six Perches then South thirty Degrees West One hundred and thirty five Perches then by a straight line to the beginning Tree containing and laid out for fifty Acres of Land more or less together with all and singular the Buildings Improvements and Appurtenances thereon or
