

③ These Presents Doth Benjamin Sellallion of the County of Anne Arundell and England unto the said Richard Snowden his Heirs Executors Admrs and assigns all the Right Title Interest and Proportion of him the said Joseph Cowman of to and in all and every the Tracts and Parcels of Land and the Buildings and Improvements as well those Contained in the said Articles as those which have been heretofore Contracted for and made for the use of the said Works and of and into all and every the Slaves Horses Waggon Materials and Implements or any other thing whatsoever which have been bought or Purchased for the use of the said Works and all the Estate Right Title Interest property or Claim whatsoever of him the said Joseph Cowman either in Law or Equity of in or to the same and every part thereof To have and to hold the said Premises to the said Richard Snowden his Heirs Executors Admrs and assigns and assigns to his and their sole use and Benefit and the said Richard Snowden for himself his Heirs Executors Admrs and assigns Doth Covenant Promise and Grant to and with the said Joseph Cowman That he the said Richard Snowden his Heirs Executors Admrs and assigns shall and will save harmless and Indemnified him the said Joseph Cowman his Heirs Executors Admrs and assigns of and from all Debts and Demands whatsoever Due for or on Account of the said Iron Works or Partnership and the said Joseph Cowman for himself his Heirs Executors Admrs and assigns Doth Promise and Grant to and with the said Richard Snowden his Heirs Executors Admrs and assigns that he the said Joseph Cowman his Heirs Executors Admrs and assigns shall and will at the Request and Charges of the said Richard Snowden his Heirs Executors Admrs and assigns make and Execute any further Act and Deed or Conveyance for the Purposes as before as the same shall Contain only a Special Warranty In Witness whereof the said Parties have hereto Interchangeably set their Hands and Seals the day and Year above written
