Release Acquit and Discharge the said Edward Smoot his Executors and Administrators
Hath granted Bargained and Sold and by these Presents Doth grant bargain and
sell unto the said Edward Smoot his Executors Administrators and Assigns All that
Tract or Parcel of Land called Penrin situate lying and being in Saint Marys County
