is hereby Acknowledged and for divers other good Causes and Considerations  
him the aforesaid Joseph Smith the Elder in this behalf moving hath given  
Granted Bargained and Sold Release and Confirmed and by those Presents —  
Doth give grant Bargain and Sell Release and Confirm Two hundred and fifty  
Acres of Plantable Land <sup>lying</sup> with the Appurtenances in Calvert County the said Two  
hundred and fifty Acres being part of a Tract or Parcel of Land called Goughs  
Purchase, And also one hundred and fifty Acres of Plantable Land lying in  
Calvert County being part of a Tract or Parcel of Land called Smiths Chance  
and also fifty Acres of Plantable Land lying with the Appurtenances in  
Calvert County being part of a Tract or Parcel of Land called Mardike  
unto the aforesaid Joseph Smith the Younger his Heirs and Assigns forever  
To have and to hold the same to the said Joseph Smith the Younger
