


Ninetoon and a half acres more or less both which said last mentioned

 Watson the wife of the aforesaid Henry Watson her Heirs and Assigns for ever
 and to and for no other Use or Uses Intents or Purposes whatsoever And the
 said James Russell for himself and his Heirs the aforesaid Tracts or Parcels of
 Land to him the said Joseph Bell his Heirs and Assigns to and for the Use
 aforesaid against all Manner of Persons claiming by him or under him
 the said James Russell and his Heirs shall and will warrant and forever
