true intent and meaning of the parties to these Presents that in case the said Daniel Rawlings his Heirs
Executors or Adm^r shall well and truly pay or cause to be paid unto the said William Hunt his Executors
Adm^r or Aisigns the said sum of two hundred forty four Pounds fifteen Shillings and four pence Sterling
with legal Interest thereon at or upon the fifth day of April which shall be in the Year of our Lord one
Thousand seven hundred fifty and five then this Deed and every Clause and Article thereon contained
shall be void and of none effect and the lands and Premises goods and chattels therein mentioned shall
be and remain in the same state and condition as if this Deed had never been made anything therein

Debt and Interest aforesd or towards so much thereof as shall at the time of such Application remain
