On the fourteenth Day of April in the Year of our Lord One Thousand Seven hundred & forty nine Before me William Tisdman Notary and Tabellion Publick Dwelling in London duly admitted and Sworn and Witnesses Personally appeared William Perkins of London Merchant who Declared to have made Ordained Constituted Authorized and appointed and by these Presents doth make Ordain constitute Authorize and appoint Thomas Harrison of the Province of Maryland at Present in London Merchant his true and Lawfull Attorney living and here by granting unto his said Attorney full Power and Lawfull Authority for him the said Constituent in his Name & for his Heirs to Ask Demand Levy Sue for & by all Lawfull ways and means Recover and Receive of and from James Perkins now or late Inhabiting in Patuxent in the said Province of Maryland Merchant his Heirs Executors or Administrators or any other Person or Persons whom it shall or may concern Inhabiting or being in the Province of Maryland of the said New York or any other Part of North America all such Sum and Sums of Money Goods Wares Merchandize Effects Estate and things which now are or shall or may hereafter be due owing Payable belonging or in anywise appertaining unto him the said Constituent whether by Bills Note Bill Book Debt Account Consignment Contract Agreement Deed Sentence Judgment Execution Latent or for any other Account Way Reason or means since or nothing in Law or Equity accepted or Resolved And to that End with the said James Perkins his Heirs Executors or Administrators or any other Person or Persons whatsoever whom it shall or may concern Inhabiting or being in the Province of Maryland of the said New York or any other Part of North America to Account and View State Settle and Adjust all Accounts and the Balance thereof to Receive And upon Recovery and Receipts to give one or more Acquittances or other sufficient Discharges in Due form of Law But in Case of Refusal or Delay by the said James Perkins his Heirs Executors or Administrators or any other Person or Persons concerned to make and Render just and true Account Payments Delivery and Satisfaction in the Premises him them any or either of them therunto to Compell by all Lawfull ways and means whatsoever (also if need be) to appear before all or any Lords Judges and Justices in any Court or Courts thereto Answer Defend and Reply in all matters and causes touching or concerning the Premises to do any Pursue Implead Seize Sequester Attach Arrest Imprison and to Condemn and out of Prison again to Deliver also to Compound conclude and agree by Arbitration or otherwise as his said Attorney shall think fit and Generally in and Concerning the Premises to do Perform and execute all and whatsoever shall be requisite and necessary as fully amply and Effectually to all Intents Constitutions and purposes as he the said Constituent might or could do if Personally Present with Power to Substitute one or more Attorneys under him with like or Limited Power and the same again to Revoke He the said William Perkins hereby Ratifying Confirming and holding for good and Valid all and whatsoever the said Thomas Harrison or his Substitutes shall Lawfully do or cause to be done in or about the Premises by Virtue of these Presents this done and Passed in London afo. in the Presence of the underwritten Witnesses
