

George Darby at or before the sealing and delivery of these presents  
 the receipt whereof the said Jeremiah Virgin doth hereby acknowledge  
 himself fully satisfied with, and for divers other good causes him hereunto  
 moving, hath given, granted & bargained, sold, aliened, enfeoffed and confirmed  
 and by these presents, doth clearly and absolutely give, grant, Bargain, &  
 sell, alien, Enfeoff, and Confirm, unto the said George Darby, his heirs &  
 assigns for ever all that part of a Tract of Land called Dickafons Delight,  
 lying formerly in Prince Georges County, but now in Frederick County, on the  
 Branches of Patuxent River commonly called and known by the name of  
 Snowdens River, & Hawlings River, bounded by the following lines.

Begining at the End of the sixth Line of Dickafons Delight & running  
 thence severall of the said line, south thirty two degrees, to Hawlings River,  
 then by and with ye said River, to the mouth of the same River, where it  
 enteres it self into the afo. River, Called Snowdens River, thence north forty  
 Degrees East eight Peches to intersect, the given line of the afo. Dickafons  
 Delight, then by and with the given line of the afo. Land severall, to the begining  
 place containing and laid out for fourteen & one quarter acres of land more or less  
 together with all meuages, Tenements, dwellings, improvements, commoditys  
 advantages and appurtenances whatsoever to the same belonging, or in any  
 wise appertaining To have and to hold the said Tract or parcel of  
 Land and Premises afo. with the appurtenances unto the said George Darby  
 his heirs and assigns forever, and the said Jeremiah Virgin for himself his  
 Heirs Executors & Administrators doth hereby Covenant Promise agree to &  
 with the said George Darby his heirs Executors Administrators and every of  
 them, by these Presents that the said Jeremiah Virgin at the time of the sealing  
 and Delivery of these Presents is seized in his demeaneur as of free of and in y<sup>e</sup>  
 before Bargained premises, with the appurtenances of a good sure and Indefay-  
 able Estate of inheritance, In full simper, free and clear of all Incumbrances what-  
 ever, and is the true and perfect owner of the said hereby Bargained Premises,  
 with the appurtenances and hath in him full power good right, & lawfull  
 Interest & authority to grant Bargain sell and assign over the same Bargained  
 premises unto the said George Darby and his heirs and assigns for ever in the  
 manner afo. that the said Jeremiah Virgin and his heirs and assigns shall and will  
 warrant & forever defend by these presents in witness whereof the parties above  
 named to these present Indenture have Interchangeable set their hand and seal  
 the day and year above written
