 be and grow due owing Payable or belonging unto me the said Andrew Reid upon or by Virtue of any
 Bond Bill Book or upon Account of Trading or dealing or upon any other Account and by any other
 ways or means whatsoever in any manner of wise and if need be to call to Account and to bring
 to a Reasoning and to Adjust and settle Accounts with all or any Person or Persons concerned
 in the Premises and to Compound or Agree for all or any Debt or Debts Sum or Sums of Money goods
 or Effects or any part thereof as he my said Attorney shall see Occasion and think fit and upon
 Receipt or Recovery of all or any the said Debts Dues Sum and Sums of Money goods and Effects or
 any of them or any part thereof sufficient Acquittances and Discharges for the same for me and in
 my Name from time to time to make and give and to remit return send and Consign all and
 every the said Monys goods and Effects which shall be from time to time recovered and received by
 Virtue of these Presents to me the said Andrew Reid at London And Generally to do negotiate
 Transact Perform and Accomplish all other Acts matters and things for me in my Name and

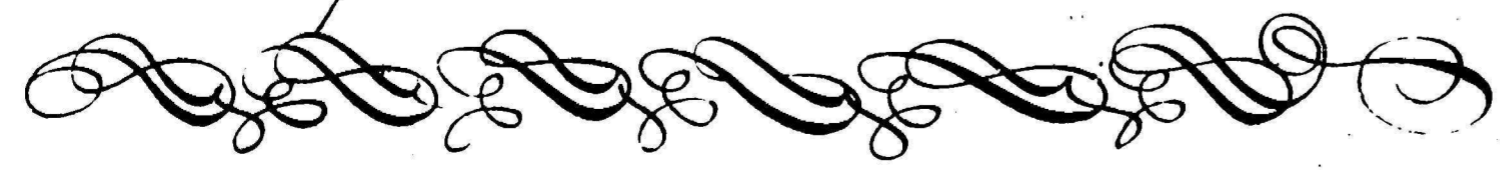
