 and Lawfull Attorney Giving and hereby Granting unto his said Attorney full Power  
 and Lawfull Authority for him the said Constituent in his name and for his use  
 to Ask Demand Levy sue for and by all lawfull ways and means recover and re-  
 ceive of and from all and every or any Person or Persons whatsoever whom it may  
 or shall Concern Inhabiting or being in the Colony of Virginia or the Province of  
 Maryland all <sup>such</sup> sums and sums of Money Goods Wares Merchandize Effects Estates  
 and things which now are or shall or may hereafter be due owing Payable belong-  
 -ing or in anywise Appertaining unto him the said Constituent whether by Bond  
 Note Bill Book Debt Account Conignment Contract Agreement decree Sentence Judg-  
 -ment execution Tolerit or for by or upon any other Account way Reason or means whatsoever  
 nothing in Law or Equity excepted or Reserved And to that end with all and every  
 -ing or any Person or Persons whatsoever whom it shall or may Concern Inhabiting  
 or being in the said Colony of Virginia or Province of Maryland to Account and  
 to New State Settle and Adjust all Accounts and the Balance thereof to receive  
 And upon Recovery and Receipts to give one or more Acquittances or other Suffici-  
 -ent Discharges in due form of Law But in case of Refusal or delay by all and every  
 or any Person or Persons whatsoever whom it shall or may Concern to make and  
 on Just and True Account Payment delivery and Satisfaction in the Premises him his  
 them any or either of them thereunto to Compell by all Lawfull ways and means  
 whatsoever Also (if Need be) to Appear before all or any Lords Judges and Justices  
 Many Court or Courts thereto to Answer defend and reply in all Matters or  
 Causes touching or concerning the Premises to do say Pursue Implead seize Sequester  
 Attach Arrest Imprison and to Condemn and out of Prison again to deliver Also  
 to Compromise Conclude and Agree by Arbitration or Otherwise as his said Attorney  
 shall think fit And Generally in and concerning the Premises to do Perform  
 and execute all and whatsoever shall be requisite and Necessary as fully as  
 ( = file )
