This Indenture made this Sixteenth day of February in the Year of our Lord one Thousand
seven hundred and Sixty five Between Orlando Smith of Prince Georges County in the Province
of Maryland of the one Part and David Rofs of the said County and Province of the other
Part Witnesseth that the said Orlando Smith for and in consideration of the said David Rofs becom-
ing Bail for his Appearance at next March Court in Prince Georges County at the Suit of
John Glastford and Co^s for Dealings at their Store in Wladensburgh under the Direction
of Richard Henderson and also to satisfy and pay a Debt due to the said Rofs from the said Orlando
Smith of fourteen Pounds fourteen Shillings and eleven Pence Maryland Currency
and also to pay a debt due to Charles Carroll Esq^r of Annapolis as Per the said Orlando
Smiths Bond dated the 15th of December 1750 for fifty Pounds Sterling lodged in the Hands of the said
David Rofs with Interest from that time as also a Debt due ^{to} John Stewart and Campbell
of London Merchants as will Appear by their Account Current as also a Debt due
to Jasper West on execution of Four Pounds five Shillings and eight Pence Maryland Currency
and two hundred and one and half pounds of Tobacco and further in the consideration of the sum
of Five Shillings to him the said Orlando Smith in hand Paid by the said David Rofs
the Receipt whereof he the said Orlando Smith doth hereby Acknowledge hath
Given Granted Bargained and Sold Aliened Released and Confirmed and by these Presents
he the said Orlando Smith for himself his Heirs Executors and Administrators doth Give
Grant Bargain Sell Alien Release and Confirm unto the said David Rofs his Heirs and
Assigns forever all that Part of a Tract of Land called Addition to Bacon Hall which
the said Orlando Smith bought of Thomas Chittams containing One hundred Acres more or less
and for which he the said Orlando Smith has Thomas Chittams Bond to Convey the same to him
the said Orlando Smith and also all that Tract or Parcel of Land called Hickory Hills Paten-
ted to Jonathan Maddum containing Two hundred and eighty nine Acres more or less as
also another Tract or Parcel of Land called Smiths Neglect Patented to Benjamin Coe
containing Sixty acres more or less lying and being in Prince Georges County with the Ap-
pointances thereunto belonging ^{following} Also the four Acres Negroes by a Negroe Woman named
Nimby and her Increase a Negroe Girl named Sall with her Increase a Negroe Boy named
Mill and a Negroe Boy named Jack these three being the Children of the said Negroe Wo-
man named Nimby To have and to hold the aforesaid Tracts of Land with the Appointman-
ces thereunto belonging and also the aforesaid Negroes Nimby Sall Mill and Jack
