be the only Right Property & Estate of the within Thomas Dinggold according
to the form Force & Effect true Intent and meaning of the said Deed, and that I

being induced thereto by Fear or Threats of, or ill usage from her said Husband, or for

Bowden ^{Robins} of the same place of the second part And Littleton Dennis
of the same place of the third part Witnesseth that the said John Scarborough
and Ann his wife and Samuel Scarborough and Peggy his wife for and in
consideration of the sum of Three hundred and fifty pounds current
money to them paid by the afo. Bowden Robins at and before the sealing
and delivery hereof the receipt whereof the said John, Ann, Samuel, and
Peggy hereby severally do acknowledge and for the further and better
confirming and confirming of the Land and Tenements with the Appurtenant-
ces hereafter mentioned for the uses and purposes intents and purposes
herein after limited expressed and declared unto the afo. Bowden
^{Robins} his heirs and assigns for ever have granted bargained and
sold released and confirmed and by this presents do give grant
bargain sell release and confirm unto the afo. Bowden ^{Robins} his
heirs and assigns for ever all that Tract or parcel of Land
Situate lying and being in Worcester County afo. on the sea board side called
and known by the Name of part of Gengollague bounded limited and
described as followeth Beginning at a marked red oak standing
on the line of a Tract of Land belonging unto the afo. Robins and from
thence running along and with the line of Virginia until it intersects the
Land of Hamon thence with a line drawn north twenty eight degrees
west bearing on the Land of Hamon to a marked red oak from thence
with a line drawn west by a line of marked trees dividing it from the
Land of Hamon until it intersects the Mill Branch thence along and
with the said Mill Branch until the said Branch intersects the line of
the afo. Robins's own Land and from thence by Lines of marked trees
dividing
