

This Indenture made this seventh Day of August in the Year of our Lord One Thousand seven hundred and sixty five — Between Leonard Greenwold of St. Mary's County Planter and — Wmifield his wife of the one Part and John Booth of the same County Planter of the other Part witnesseth that for and in consideration of the sum of five Shillings Current Money to the said Leonard Greenwold and Wmifield his wife on hand at or before the sealing and delivery of these presents by the said John Booth well and truly paid the receipt whereof is hereby Acknowledged. The said Leonard Greenwold and Wmifield his wife have bargained and sold and by those presents do bargain and sell unto the same John Booth his Executors Administrators and Assigns all those Two Tracts or Parcels of Land lying in the County aforesaid Part of Hanover Addition and known by the name of Wmifield Mount The one beginning at a Shrub White Oak standing by a fence called Greenwolds Fence — running thence East forty paces to the said Greenwolds spring thence East thirty five Degrees South one hundred and forty three paces to a bound oak standing in the first Line of Hanovers addition then west forty eight paces thence North seventy Degrees West one hundred and forty two paces then to the Beginning containing fifty one acres of land more or less and also one other Tract or parcel of plantable land part of Hanovers addition beginning at a bound oak standing in the same nail many Peaks — running thence East seventy seven paces to the aforesaid Greenwolds Spring thence North thirty six Degrees West fifty four paces with the Branch to Garman's Run with the said Run to Peake's Mill thence to the Beginning containing Twenty two acres of land more or less together with all the houses Edifices Buildings — Improvements ways waters water Courses orchards Woods under woods Privileges Commodities Advantages and Appurtenances to the same appertaining or in any wise belonging and the Reversion and Reversions Remainder and Remainders Rents Issues and Profits of all and Singular the said Premises and every Part or Parcel thereof with their and every of their Rights Members and Appurtenances to have and to hold the same Tract or parcel of Lands and all and Singular other the Premises herein before mentioned or intended to be hereby bargained or sold with their and every of their Rights members and Appurtenances unto the same John Booth his Executors Administrators and Assigns from the Day next before the Day of the Date of these presents for and during the Term of one whole year from the same next ensuing fully to be compleat and ended To the Intent and purpose that by Virtue of these presents and of the Statute for transferring less into possession the said John Booth may be in the actual possession of all and Singular the said hereby bargained Premises with
