**Charter Amendment
Resolution No. 45**

A RESOLUTION of the Mayor and City Council of Cumberland, Maryland, adopted pursuant to the authority contained in Article 11-E of the Constitution of the State of Maryland, and Section 13 of Article 23A of the Annotated Code of Maryland, entitled "Municipal Corporations," as said Section was enacted by Chapter 423 of the Acts of the General Assembly of Maryland, 1955, entitled "A RESOLUTION TO AMEND THE CHARTER OF THE CITY OF CUMBERLAND, MARYLAND (1966 EDITION), BY REPEALING AND REENACTING, WITH AMENDMENTS, SECTIONS 49, 55(c), 56, 57, 58 and 58A of SAID CHARTER, FOUND UNDER THE SUBTITLE 'CIVIL SERVICE—FIRE AND POLICE' AND TO ADD A NEW SECTION TO BE KNOWN AS 58B, ALL OF WHICH DEAL WITH THE COMPENSATION, SALARIES, SICK LEAVE, HOLIDAYS AND VACATIONS OF CITY EMPLOYEES."

Section 1. BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF CUMBERLAND, That Sections 49, 55(c), 56, 57, 58 and 58A of the Charter of the City of Cumberland (1966 Edition) be and are hereby repealed and reenacted to read as follows:

49. All eligible city employees shall be allowed paid leave on account of illness in such amounts as the Mayor and City Council may prescribe from time to time. Said periodic amounts and accumulated totals shall be set forth by Ordinance.

55(c). Each member of the police department shall be required to work a regular tour of duty in accordance with a three-platoon system. Provision shall be made that each member shall be granted two days off in each work week, to be designated by the Chief of Police.

56(a). Each member of the fire department shall be required to work a regular tour of duty in accordance with the two-platoon system. In no event shall the regular tour of duty schedule require more than an average of a fifty-six (56) hour work week.

56(b). Salaries for the various positions and classifications in the fire department shall be those established from time to time by Ordinance of the Mayor and City Council and set forth in the City Code under Article I of the Chapter on Personnel.

57. Salaries for the various positions and classifications in the police department shall be those established from time to time by Ordinance of the Mayor and City Council and set forth in the City Code under Article I of the Chapter on Personnel.

58. Any permanent employee of the City of Cumberland, who is injured in the performance of his duty, shall receive compensation for such time as he may be prevented from performing such duties because of the injuries so received, agreeable to the Workmen's Compensation Laws
