Be It Enacted by the County Council for Montgomery County, Maryland, that—

Section 1. Section 44-12, Chapter 44, title "Silver Spring, Bethesda, Wheaton and Montgomery Hills Parking Lot Districts," of the Montgomery County Code 1965, is hereby repealed and re-enacted, with amendments, to read as follows:
