

BRANCH OF THE COUNTY AND TO APPOINT AND REMOVE *THE DIRECTOR OF THE DEPARTMENT OF COMMUNITY AND INDUSTRIAL AFFAIRS*, THE DIRECTOR OF ADMINISTRATION, THE COUNTY SOLICITOR, THE PLANNING AND ZONING OFFICER, ZONING HEARING OFFICER, DIRECTOR OF PUBLIC WORKS, DIRECTOR OF INSPECTIONS AND PERMITS, CHIEF OF POLICE, FIRE ADMINISTRATOR AND THE DIRECTOR OF RECREATION AND PARKS WHO SHALL BE DIRECTLY RESPONSIBLE TO HIM.

*Section 4.* AND BE IT FURTHER ENACTED, That at the next general election to be held in this State on November 3, 1970, the foregoing section hereby proposed as an amendment to the Charter of Anne Arundel County, shall be submitted to the legal and qualified voters of Anne Arundel County for their adoption or rejection pursuant to Section 1202 of the Charter of Anne Arundel County and at the said general election, the vote on the said proposed amendments to the Charter shall be by ballot; and upon each ballot there shall be printed the words "For the Charter Amendment" and "Against the Charter Amendment". If a majority of the votes cast in said election shall be in favor of the proposed amendment, such amendment shall stand adopted from and after the thirtieth (30th) day following said election; but if a majority of the votes cast in the election shall be against the proposed amendment, then the provisions of this ordinance shall be null and void and of no effect.

**Bill No. 86-70**

An Ordinance to add new Sections 13-370 through 13-370.8, inclusive, to the Anne Arundel County Code (1967 Edition and Supplement), title 13, "Planning and Zoning," subtitle 3, "Zoning," to follow immediately after Section 13-330.3 thereof (as enacted by Bill No. 55-70) under the new Article XII, "Site Plan Review," generally setting forth the requirements for site plans; providing for the adoption of zoning maps; authorizing the renumbering of such sections of this Ordinance as may be necessary or desirable when additional sections of this subtitle are adopted; providing that this Ordinance shall become effective only ~~upon the adoption of the entire~~ AFTER SAID subtitle and ~~the repealer of ZONING MAPS ARE~~ ADOPTED AND BECOME EFFECTIVE, AND the existing Zoning ~~law~~ LAWS ARE REPEALED; and matters generally related thereto.

WHEREAS, The Charter of Anne Arundel County, Maryland, provides that the life of a bill is sixty-five (65) days; and

WHEREAS, It is impractical and unrealistic to attempt to have intelligent and meaningful public hearings on a complete Zoning Ordinance within said sixty-five (65) day period, it is the intent of the County Council of Anne Arundel County, Maryland, to adopt Subtitle 3, "Zoning", in sections, no section becoming effective until the complete subtitle is adopted.

*Section 1.* BE IT ENACTED BY THE COUNTY COUNCIL OF ANNE ARUNDEL COUNTY, MARYLAND, That new Sections 13-370 through 13-370.8, inclusive, be and they are hereby added to the Anne
