NORTHERLY ON PRINCE ROAD; THENCE EASTERLY ON JOPPA ROAD TO ITS INTERSECTION WITH LOCH RAVEN BOULEVARD; THENCE SOUTHERLY ON LOCH RAVEN BOULEVARD TO PUTTY HILL AVENUE; THENCE WESTERLY ON PUTTY HILL AVENUE TO PLEASANT PLAINS ROAD; THENCE SOUTHERLY ON PLEASANT PLAINS ROAD TO COTTAGE AVENUE; THENCE SOUTHEASTERLY ON COTTAGE AVENUE TO LOCH RAVEN BOULEVARD; THENCE SOUTHERLY ON LOCH RAVEN BOULEVARD TO THE BALTIMORE CITY LINE.

THE SECOND CONGRESSIONAL DISTRICT SHALL ALSO CONSIST OF THE FOLLOWING REGIONS OF BALTIMORE CITY:

- (A) WARD 27. PRECINCTS 86 THROUGH 90, AND 103, 104, 105; AND
 - (B) WARD 28. PRECINCT 2-B

The third congressional district shall consist of the following regions of Baltimore City and Baltimore County:

- (1) Wards 1, 2, 3, 4, 5, 6, 18, 21, 22, 23, 24, 25 and 26 in their entirety;
 - (2) Ward 7. Precincts 1, 2, 9, 10, 13, 14, 15 and 16 of Ward 7;
- (3) Ward 8. Precincts 1, 2, 3, 4, 5, 6, 22, 23, 24 25 and 26 of Ward 8;
 - (4) Ward 20. Precinct 13 of Ward 20:
- (5) Ward 27. Precincts 1 through 28 inclusive, and precincts 23 through 38, inclusive, of Ward 27.
- (4) WARD 6. PRECINCTS 1 THROUGH 4 AND 7 THROUGH 14 INCLUSIVE.
 - (b) Baltimore County:
 - (1) Election districts 12 and 13 in their entirety:
- (2) That part of election district 15 which lies within the United States Bureau of the Census 1970 tracts 4519, 4520, 4521, 4522, 4522.00, 4523, 4524 and 4525, which part is generally described in Section 22 4 of this Article.
- (5) WARD 9, PRECINCTS 1, 2, 3, 4, 5, 26, 27, 28, 29, 30 AND 31 OF WARD 9;
- (6) WARD 12. PRECINCTS 1, 2, 3, 4, 21, 22, 23, 24 OF WARD 12.
 - (7) WARD 20. PRECINCT 13 OF WARD 20.
