or invalidity had been known; and to this end, all parts, sections, and parts of sections of this Act are declared to be severable.

SEC. 6. And be it further enacted, That all laws or parts of laws, public general or public local, inconsistent with the provisions of this Act, are hereby repealed to the extent of any such inconsistency.

SEC. 7. And be it further enacted, That this Act shall take effect July 1, 1972.
