CHAPTER 394

(Senate Bill 203)

AN ACT to repeal and re-enact, with amendments, Section 240F of Article 48A of the Annotated Code of Maryland (~~1971 Supplement~~), (1972 REPLACEMENT VOLUME), title "Insurance Code," subtitle "15. Unfair Trade Practices," to prohibit any CANCELLATION, NON-RENEWAL OR increase in the premium charge for a policy or contract of motor vehicle liability insurance exclusively for the reason of age of the holder of BEYOND 65 OF AN INSURED UNDER the policy or contract, OR NON-RENEWAL OF A MOTOR VEHICLE INSURANCE POLICY OR CONTRACT EXCLUSIVELY FOR THE REASON OF AGE OF THE HOLDER OF THE POLICY OR CONTRACT, OR INCREASE THE PREMIUM THEREFOR EXCLUSIVELY FOR THE REASON OF AGE BEYOND 65 YEARS OF AN INSURED UNDER THE POLICY OR CONTRACT.

SECTION 1. *Be it enacted by the General Assembly of Maryland*, That Section 240F of Article 48A of the Annotated Code of Maryland (~~1971 Supplement~~), (1972 REPLACEMENT VOLUME), title "Insurance Code," subtitle "15. Unfair Trade Practices," be and it is hereby repealed and re-enacted, with amendments, to read as follows:

240F.

No policy or contract of motor vehicle liability insurance shall be cancelled or nonrenewed or premium therefor increased exclusively for the reason of age of the holder of BEYOND 65 OF AN INSURED UNDER OF THE HOLDER OF the policy or contract, NOR SHALL ANY PREMIUM THEREFOR BE INCREASED EXCLUSIVELY FOR THE REASON OF AGE BEYOND 65 YEARS OF AN INSURED UNDER THE POLICY OR CONTRACT.

SEC. 2. *And be it further enacted*, That this Act shall take effect July 1, 1972.
