

thereto, providing that the county may borrow funds and under certain procedures impose benefit assessments and other charges and taxes to repay the same; and relating generally to the Sanitary District of Cecil County and to the operation of the sanitary district within Cecil County TO ENACT IN LIEU THEREOF NEW SECTIONS 19-1 TO 19-31, TO STAND IN THE PLACE OF THE SECTIONS SO REPEALED; SAID NEW SECTIONS PROVIDING FOR THE ESTABLISHMENT OF A SANITARY DISTRICT IN CECIL COUNTY TO BE UNDER THE JURISDICTION OF THE COUNTY COMMISSIONERS OF SAID COUNTY AND CONFERRING UPON SAID COUNTY COMMISSIONERS THE POWER AND AUTHORITY TO CONSTRUCT, OPERATE AND MAINTAIN WATER AND SEWERAGE SYSTEMS AND DRAINAGE SYSTEMS WITHIN SUCH PARTS OF CECIL COUNTY OTHER THAN IN ANY MUNICIPAL CORPORATION EXCEPT AS PROVIDED HEREIN; PROVIDING FOR THE APPOINTMENT OF A DIRECTOR OF SANITARY FACILITIES; DEFINING THE POWERS, DUTIES, OBLIGATIONS, RIGHTS AND FUNCTIONS OF SAID DIRECTOR OF SANITARY FACILITIES AND THE SAID COUNTY COMMISSIONERS; CONFERRING THE POWER TO SET AND ESTABLISH SERVICE AND OTHER CHARGES, FRONT FOOT ~~BENEFITS~~ BENEFIT ASSESSMENTS AND AD VALOREM TAXES BY THE SAID COUNTY COMMISSIONERS FOR THE PURPOSE OF PAYING OPERATION AND CAPITAL COSTS TO BE INCURRED UNDER THE PROVISIONS OF THIS SUBTITLE; PROVIDING FOR THE ISSUANCE AND SALE OF BONDS BY THE COUNTY COMMISSIONERS OF CECIL COUNTY, THE PROCEEDS OF WHICH ARE TO BE USED IN CONNECTION WITH THE FINANCING OF WATER AND SEWERAGE SYSTEMS UNDER THE PROVISIONS OF THIS SUBTITLE; AND RELATING GENERALLY TO THE CECIL COUNTY SANITARY DISTRICT.

SECTION 1. *Be it enacted by the General Assembly of Maryland,* That Sections 19-1 to 19-25 inclusive, of the Code of Public Local Laws of Cecil County (being Article 8 of the Code of Public Local Laws of Maryland), 1970 as amended, title "Cecil County" subtitle "Sanitary District DISTRICTS," be and they are hereby repealed, ~~and new Sections 19-1 to 19-41 be and they are hereby enacted,~~ in the place of the sections so repealed; all to read as follows:

SEC. 2. *BE IT FURTHER ENACTED,* THAT NEW SECTIONS 19-1 TO 19-31, INCLUSIVE, ARE HEREBY ADDED TO THE CODE OF CECIL COUNTY, MARYLAND (1970 EDITION, AS AMENDED, BEING ARTICLE 8 OF THE CODE OF PUBLIC LOCAL LAWS OF MARYLAND) TITLE "CECIL COUNTY," SUBTITLE "CECIL COUNTY SANITARY DISTRICT," TO STAND IN THE PLACE OF THE SECTIONS REPEALED AND ALL TO READ AS FOLLOWS:

#### SANITARY DISTRICT

##### 19-1. *Sanitary District.*

(A) *Cecil County is HEREBY declared to be a sanitary district for the purpose of the exercise of the powers vested by this subtitle*
