BE IT FURTHER RESOLVED, ENACTED and ORDAINED by the Cottage City Commissioners of the Town of Cottage City, Maryland, that the aforegoing proposed amendment shall be posted in the Town Hall for a period of at least forty (40) days following its adoption, and shall further be published in the Prince George's Post once in each of four successive weeks before the 21st day of May, 1971.

BE IT FURTHER RESOLVED, ENACTED and ORDAINED by the Cottage City Commissioners of the Town of Cottage City, Maryland, that the proposed amendment will become and be considered a part of the Municipal Charter of the Town of Cottage City on the 7th day of June, 1971, unless a petition is filed pursuant to Article 23(a), Section 13 of the Annotated Code of Maryland, 1957 Edition and 1966 Replacement Volume of said Code, as amended, said petition to be filed on or before the 26th day of May, 1971.
