

(G) MAP NO. 29 R BE, AND IT IS HEREBY AMENDED AS FOLLOWS, SAID AMENDMENT BEING DESIGNATED ON SAID MAP AS "(A-3) AND (E-10)":

CHANGE THE DR. BARTON W. ROHRBACH PROPERTY FROM CIB—COMMUNITY RETAIL DISTRICT TO C4—HIGHWAY COMMERCIAL DISTRICT, SAID PROPERTY BEING DESCRIBED AS FOLLOWS: BEGINNING FOR THE SAME AT THE EASTERN BOUNDARY OF PROPOSED ZONE 23-C4-4; THENCE EASTERLY BINDING THE SOUTH SIDE OF RT. 214, 100 FEET, MORE OR LESS, TO THE EASTERN PROPERTY LINE OF A PARCEL OF LAND OWNED BY BARTON W. ROHRBACH AS RECORDED AMONG THE LAND RECORDS OF ANNE ARUNDEL COUNTY, MARYLAND, LIBER 1996, FOLIO 82; THENCE SOUTHERLY AND BINDING SAID PROPERTY LINE 300 FEET, MORE OR LESS, TO THE SOUTHEAST CORNER OF SAID PARCEL; THENCE WESTERLY 100 FEET, MORE OR LESS, TO THE EASTERN BOUNDARY LINE OF SAID PROPOSED ZONE; THENCE NORTHERLY 300 FEET TO THE PLACE OF BEGINNING.

(H) MAP NO. 32 W BE, AND IT IS HEREBY AMENDED AS FOLLOWS, SAID AMENDMENT BEING DESIGNATED ON SAID MAP AS "(B-15)":

CHANGE THE PAULINE ALVEY PROPERTY FROM R2—RESIDENTIAL DISTRICT TO CIB—COMMUNITY RETAIL DISTRICT, SAID PROPERTY BEING DESCRIBED AS FOLLOWS: BEGINNING FOR THE SAME AT THE SOUTHEAST CORNER OF MAYO RIDGE ROAD AND RT. 214, THENCE SOUTHERLY 578.54 FEET; THENCE AT RIGHT ANGLE TO SAID ROAD EASTERLY 200 FEET; THENCE NORTHERLY 550 FEET, MORE OR LESS, TO THE SOUTH SIDE OF MAYO RIDGE ROAD; THENCE WESTERLY AND BINDING SAID SIDE OF SAID ROAD TO THE PLACE OF BEGINNING.

(I) MAP NO. 32 W BE, AND IT IS HEREBY AMENDED AS FOLLOWS, SAID AMENDMENT BEING DESIGNATED ON SAID MAP AS "(B-18)":

CHANGE THE CLYDE RICKMAN PROPERTY FROM R2—RESIDENTIAL DISTRICT TO CIB—COMMUNITY RETAIL DISTRICT, SAID PROPERTY BEING DESCRIBED AS FOLLOWS: BEGINNING AT A POINT ON MAYO ROAD (MD. RT. 214) APPROXIMATELY 800 FEET SOUTHERLY FROM GATTS CORNER; THENCE HEADING (1) NORTH 20 DEGREES 59 MINUTES EAST 260.21 FEET TO A POINT ON SAID ROAD; (2) THENCE LEAVING SAID ROAD NORTH 67 DEGREES 44 MINUTES 30 SECONDS WEST 400 FEET TO A POINT (3) THENCE HEADING SOUTH 21 DEGREES 35 MINUTES WEST 267.30 FEET TO A POINT (4) THENCE HEADING SOUTH 68 DEGREES 33 MINUTES EAST 398.97 FEET TO THE POINT OF BEGINNING ON SAID ROAD.
