

(A) MAP NO. 36 V BE, AND IT IS HEREBY AMENDED AS FOLLOWS, SAID AMENDMENT BEING DESIGNATED ON SAID MAP AS "(A-9)":

CHANGE THE WILLIAM J. GROOM PROPERTY FROM MB-MARITIME GROUP B DISTRICT TO MC-MARITIME GROUP C DISTRICT, SAID PROPERTY BEING DESCRIBED AS FOLLOWS:

BEGINNING FOR THE SAME AT THE POINT WHERE THE EASTERN BOUNDARY OF ZONING DISTRICT 30-MC-3 INTERSECTS WITH THE SOUTH SIDE OF FORD ROAD; THENCE WESTERLY BINDING ALONG SAID BOUNDARY OF SAID ROAD 300 FEET, MORE OR LESS, TO THE WESTERN BOUNDARY OF SAID ZONING DISTRICT; THENCE SOUTHERLY 420 FEET, MORE OR LESS, TO BINDING ALONG SAID WESTERN BOUNDARY OF SAID DISTRICT TO THE NORTHERN SHORE OF PAUSH CREEK; THENCE MEANDERING ALONG SAID SHORE LINE 250 FEET, MORE OR LESS, TO THE EASTERN BOUNDARY OF SAID ZONING DISTRICT; THENCE NORTHERLY BINDING ALONG SAID EASTERN BOUNDARY OF SAID ZONING DISTRICT 300 FEET MORE OR LESS TO THE PLACE OF BEGINNING.

(B) MAPS NOS. 36 V AND W AND 37 V AND W BE, AND THEY ARE HEREBY AMENDED AS FOLLOWS, SAID AMENDMENT BEING DESIGNATED ON SAID MAPS AS "(A-10)":

CHANGE THE DONALD R. WEBB PROPERTY FROM MB-MARITIME GROUP B DISTRICT TO MC-MARITIME GROUP C DISTRICT, SAID PROPERTY BEING DESCRIBED AS FOLLOWS: BEING ALL THAT PROPERTY OWNED BY DONALD R. WEBB AND RECORDED IN THE LAND RECORDS OF ANNE ARUNDEL COUNTY, MARYLAND, LIBER 2071, folio 39 and liber 2270, folio 577 (ROY'S BOATHOUSE ON PARISH CREEK).

(C) MAPS NOS. 36 W AND 37 W BE, AND THEY ARE HEREBY AMENDED AS FOLLOWS, SAID AMENDMENT BEING DESIGNATED ON SAID MAPS AS "(A-11)":

CHANGE THE KENNETH R. NIEMAN AND OTHERS PROPERTY FROM MB-MARITIME GROUP B DISTRICT TO W2-LIGHT INDUSTRIAL DISTRICT, SAID PROPERTY BEING DESCRIBED AS FOLLOWS: BEING ALL OF THAT LAND IN THE ZONING DISTRICT 30-MB-3 OF THE PROPOSED COMPREHENSIVE ZONING MAPS. SAVING AND EXCEPTING THOSE PARCELS OF LAND OWNED BY DONALD R. WEBB AND RECORDED IN THE LAND RECORDS OF ANNE ARUNDEL COUNTY, MARYLAND, LIBER 2071, FOLIO 39 AND LIBER 2270, FOLIO 577. LAND AT HEAD OF PARISH CREEK AND SNUG HARBOR ROAD.
