(A) MAP NO. 43 S ONLY THAT PART LYING WITHIN THE EIGHTH ASSESSMENT DISTRICT BE, AND IT IS HEREBY AMENDED AS FOLLOWS, SAID AMENDMENT BEING DESIGNATED ON SAID MAP AS "(A-13)":

CHANGE THE ROBERT D. HUFFMAN PROPERTY FROM R1—RESIDENTIAL DISTRICT TO MB—MARITIME GROUP B DISTRICT, SAID PROPERTY BEING DESCRIBED AS FOLLOWS: BEGINNING FOR THE SAME AT A POINT AT THE SOUTHWEST CORNER OF ZONING DISTRICT 32-MB-4; THENCE IN A NORTHERLY DIRECTION BINDING ON THE WESTERN BOUNDARY OF SAID ZONE 200 FEET, MORE OR LESS, TO THE SOUTHWEST CORNER OF 32-MC-1; THENCE BINDING ALONG THE WESTERN BOUNDARY OF SAID ZONE 280 FEET, MORE OR LESS TO THE NORTHERN BOUNDARY OF SAID ZONE; THENCE WESTERLY BINDING PARALLEL TO AND 25 FEET FROM THE NORTHERN BOUNDARY OF THAT PROPERTY OWNED BY ROBERT D. HUFFMAN AND RECORDED IN THE LAND RECORDS OF ANNE ARUNDEL COUNTY, MARYLAND, LIBER 2252, FOLIO 414, FOR A DISTANCE OF 400 FEET, MORE OR LESS, TO A POINT 25 FEET FROM AND PARALLEL TO THE WESTERN BOUNDARY OF SAID PARCEL; THENCE SOUTHERLY 660 FEET, MORE OR LESS, BINDING ALONG A LINE PARALLEL TO AND 25 FEET FROM THE WESTERN BOUNDARY OF SAID PARCEL TO A POINT 135 FEET, MORE OR LESS, FROM THE SOUTHERN BOUNDARY LINE OF SAID PARCEL; THENCE EASTERLY IN A STRAIGHT LINE TO THE POINT OF BEGINNING, A DISTANCE OF 580 FEET, MORE OR LESS.
