CHANGE THE GEORGE WAYSON. WAYSON'S CORNER, INC. PROPERTY FROM RA—AGRICULTURAL RESIDENTIAL DISTRICT TO C4—HIGHWAY COMMERCIAL DISTRICT. SAID PROPERTY BEING DESCRIBED AS FOLLOWS: BEGINNING FOR THE SAME AT THE INTERSECTION OF THE NORTH SIDE OF RT. 4 AND THE SOUTHEAST CORNER OF A PARCEL OF LAND OWNED BY GEORGE WAYSON AS RECORDED IN THE LAND RECORDS OF ANNE ARUNDEL COUNTY, MARYLAND, LIBER 2020, FOLIO 176; THENCE WEST AND BINDING THE NORTH SIDE OF RT. 4. 450' ± TO THE EAST SIDE OF AN UN-NAMED 10 FOOT RIGHT OF WAY, SAID RIGHT OF WAY BEING 80' ± EAST OF THE RT. 4 AND RT. 416 INTERSECTION: THENCE NORTH AND BINDING THE EAST SIDE OF HERE-TOFORE MENTIONED RIGHT OF WAY 210 FEET: THENCE EASTERLY AND AT RIGHT ANGLES TO SAID RIGHT OF WAY AND PARALLEL TO RT. 4, 450' ± TO THE NORTHEAST CORNER OF HERETOFORE MENTIONED GEORGE WAYSON PROP-ERTY; THENCE SOUTHERLY AND BINDING THE EAST PROPERTY LINE OF SAID PROPERTY 210' ± TO THE NORTH SIDE OF RT. 4.

CHANGE THE MARYLAND TOBACCO GROWERS ASSOCIATION PROPERTY FROM C4—HIGHWAY COMMERCIAL DISTRICT, RA—AGRICULTURAL RESIDENTIAL DISTRICT TO C4—HIGHWAY COMMERCIAL DISTRICT, SAID PROPERTY BEING DESCRIBED AS FOLLOWS: BEING ALL THAT PROPERTY OWNED BY MARYLAND TOBACCO GROWERS ASSOCIATION AS RECORDED AMONG THE LAND RECORDS OF ANNE ARUNDEL COUNTY, MARYLAND, LIBER 225, FOLIO 230.

SECTION 2. And be it further enacted, That a certified copy of said Comprehensive Zoning Maps shall be permanently kept on file in the Office of the Secretary to the County Council, and a true test copy shall be permanently kept on file in the Office of Planning and Zoning.

SECTION 3. And be it further enacted, That Subtitle 3, "Zoning Regulations", of Title 13, "Planning and Zoning", of the Anne Arundel County Code (1967 Edition and Supplements), formerly codified as Chapter 35, of said Code (1957 Edition and Supplements, as added or amended), be, and it is hereby repealed to the extent that the provisions of said Subtitle affect the Eighth Assessment District (said Subtitle and Zoning Maps having been previously repealed to the extent that they affect the First and Seventh
