

FIRE-FIGHTING FORCE OR THE AIRPORT POLICE FORCE SHALL BECOME MEMBERS OF THE BALTIMORE CITY FIRE AND POLICE EMPLOYEES RETIREMENT SYSTEM AND THE ADMINISTRATION SHALL REIMBURSE THE CITY FOR THE EMPLOYER'S COST OF SUCH PENSION COVERAGE.

SEC. 10. *AND BE IT FURTHER ENACTED, THAT SECTIONS 1 THROUGH 20, INCLUSIVE, AND SECTION 21 (X), 22, 23, 23A, 24 AND 25 OF ARTICLE 62C OF THE ANNOTATED CODE OF MARYLAND (~~1971 SUPPLEMENT~~) (1972 REPLACEMENT VOLUME), TITLE "FRIENDSHIP INTERNATIONAL AIRPORT AUTHORITY," BE AND THEY ARE HEREBY REPEALED IN THEIR ENTIRETY.*

SEC. 11. *AND BE IT FURTHER ENACTED, THAT SUBSECTIONS (B), (C), (E), (F)(3), (F)(4), (H), (J)(4), (L), (N)(1), AND (O) OF SECTION 21 OF ARTICLE 62C OF THE ANNOTATED CODE OF MARYLAND (~~1971 SUPPLEMENT~~) (1972 REPLACEMENT VOLUME), TITLE "FRIENDSHIP INTERNATIONAL AIRPORT AUTHORITY," BE AND THEY ARE HEREBY REPEALED AND RE-ENACTED, WITH AMENDMENTS, AND THAT THE TITLE OF SAID ARTICLE 62C BE AND IT IS HEREBY CHANGED TO READ "MARYLAND AIRPORT ZONING BOARD," AND ALL TO READ AS FOLLOWS:*

ARTICLE 62C

(B) SUBJECT TO THE APPLICABLE RULES, RESTRICTIONS, GUIDES AND STANDARDS ESTABLISHED BY THIS SECTION, ALL OF THE POWER AND AUTHORITY CONFERRED UPON THE MAYOR AND CITY COUNCIL OF BALTIMORE OR ANNE ARUNDEL COUNTY BY SECTION 16 OF ARTICLE 1A OF THE ANNOTATED CODE OF MARYLAND TO ADOPT, REVISE, ADMINISTER AND ENFORCE AIRPORT ZONING REGULATIONS TO PROTECT THE AERIAL APPROACHES OF ANY AIRPORT LOCATED, IN WHOLE OR IN PART, WITHIN THE LIMITS OF ANNE ARUNDEL COUNTY IS HEREBY DELEGATED TO THE SAID AIRPORT ZONING BOARD; PROVIDED, HOWEVER, THAT ALL SAID POWER AND AUTHORITY HEREBY DELEGATED TO THE SAID AIRPORT ZONING BOARD AND ALL OTHER BOARDS, COMMISSIONS OR OTHER AGENCIES MENTIONED IN THIS SUBTITLE SHALL BE EXERCISED BY THEM ONLY IN CONNECTION WITH AIRPORTS LOCATED, IN WHOLE OR IN PART, IN ANNE ARUNDEL COUNTY AND OWNED BY THE STATE OF MARYLAND, AND SHALL INCLUDE THE FRIENDSHIP INTERNATIONAL AIRPORT AUTHORITY AND ANY LAND FALLING WITHIN THE TERRITORIAL JURISDICTION OF SUCH AUTHORITY]. THE SAID AIRPORT ZONING BOARD, IN EXERCISING ANY OR ALL OF THE POWER AND AUTHORITY HEREBY DELEGATED TO IT, SHALL AT ALL TIMES AND IN ALL RESPECTS COMPLY WITH ALL OF THE TERMS, CONDITIONS AND PROVISIONS CONTAINED IN THE AFOREMENTIONED ARTICLE AND IN THIS SUBTITLE.
