*(j-1) In St. Mary's County, the Board of license commissioners may issue a special on-sale beer, wine and liquor permit to any bona fide religious, fraternal, civic, veterans', hospital or charitable organization for a period not exceeding one day, subject to any conditions the board of license commissioners may impose on the issuance of this permit. The fee for this permit is \$5.00.*

SEC. 2. *And be it further enacted, That this Act shall take effect July 1, 1972.*

CHAPTER 342

(Senate Bill 581)

AN ACT to add new Sections 430 through 437 to Article 41 of the Annotated Code of Maryland (1971 Replacement Volume and 1971 Supplement), title "Governor—Executive and Administrative Departments," to be under the new subtitle "41. The Department of Agriculture"; to repeal and re-enact, with amendments, Section 201 of said Article and title, subtitle "The State Board of Agriculture and the Regents of the University of Maryland," to be under the new subtitle "The Regents of the University of Maryland"; TO REPEAL AND RE-ENACT, WITH AMENDMENTS, SECTION 150 OF ARTICLE 43 OF THE ANNOTATED CODE OF MARYLAND (1971 REPLACEMENT VOLUME), TITLE "HEALTH," SUBTITLE "STATE BOARD OF VETERINARY MEDICAL EXAMINERS"; to repeal and re-enact, with amendments, Section 15(b) of Article 77A of the Annotated Code of Maryland (1969 Replacement Volume and 1971 Supplement), title "Higher Education," subtitle "University of Maryland"; to repeal and re-enact, with amendments, Section 9, 10, 11(a), 11(b), 43, 56, 58(a), 61(k), 63, 64, 74 through 79, 81 through 85, 96, 97, 98 and 101, AND 144(A) of Article 48 of the Annotated Code of Maryland (1971 Replacement Volume), title "Inspections," subtitles "Tobacco," "State Tobacco Authority," "State Horticultural Department," "Tree and Fruit Inspectors—The Yellows'," and "Agricultural Lime"; to repeal Sections 70 through 73, 86, 95, 100 and 157(c) of said article and title, subtitles "State Horticultural Department," "Tree and Fruit Inspectors—The Yellows'," and "Seed"; to repeal and re-enact, with amendments, Sections 47A, 54, 61, 62, 63, 64, 72, 73, 74, 75, 76, 78, 79, 80, 82 and 91(a) of Article 66C of the Annotated Code of Maryland (1970 Replacement Volume and 1971 Supplement), title "Natural Resources," subtitle "Agriculture," subheadings "In General," "Agriculture Fair Associations," "Drainage," "Fruits and Vegetables," and "Soil Conservation Districts"; to repeal Sections 46, 47, 52 and 53 of said article, title and subtitle, subheading "In General"; to repeal Section 415 of said article and title, subtitle "Livestock," subheading "State Board of Agriculture"; to repeal and re-enact, with amendments, Sections 4, 6, 72, 73(a), 73(d) and 80 of Article 97 of the Annotated Code of Maryland
