(2) "HOME HEMODIALYSIS PATIENT" MEANS A PERSON WHO HAS BEEN TAUGHT WITH ANOTHER INDIVIDUAL PERSONALLY COMMITTED TO THAT PATIENT'S TREATMENT IN A HOME DIALYSIS TRAINING FACILITY TO PROVIDE HIS OWN HEMODIALYSIS TREAT AT HOME.

(L-1) SALES OF HEMODIALYSIS DRUGS AND DEVICES SOLD BY REGISTERED PHARMACISTS OR JOBBERS, DISTRIBUTORS, WHOLESALERS, MANUFACTURERS, OR OTHER SUPPLIERS OF HEMODIALYSIS DRUGS AND DEVICES PERMITTED BY SECTION 270B OF ARTICLE 43 OF THE CODE, DIRECTLY TO PATIENTS WHO REQUIRE REGULAR TREATMENT IN THEIR HOMES BY A KIDNEY MACHINE BECAUSE OF THE PERMANENT LOSS OF THE FUNCTION OF THEIR KIDNEYS.

(F) RENTALS OF KIDNEY MACHINES, INCLUDING DIALYZERS, DELIVERY SYSTEMS AND THEIR ACCESSORY EQUIPMENT, AND OTHER HEMODIALYSIS PRODUCTS, ON ORDER BY A LICENSED PHYSICIAN AND PURSUANT TO SECTION 270B OF ARTICLE 43 OF THIS CODE, BY PERSONS WHO REQUIRE REGULAR TREATMENT, IN THEIR HOMES, BY A KIDNEY MACHINE BECAUSE OF THE PERMANENT LOSS OF THE FUNCTION OF THEIR KIDNEYS.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 1973.
