PURSUANT TO THE PROVISIONS OF ARTICLE 66C, SECTION 345B, ALL THAT PROPERTY SITUATE IN GARRETT COUNTY, MARYLAND, CONTAINING APPROXIMATELY 2,000 ACRES AND DESCRIBED AS FOLLOWS IS HEREBY DECLARED A TYPE I STATE WILDLAND, AND IT SHALL BE NAMED THE "BIG SAVAGE MOUNTAIN WILDLAND".

BEGINNING AT THE WHITE WATER PRIMITIVE CAMPING AREA AND PROCEEDING COUNTERCLOCKWISE (S75°E) APPROXIMATELY 4,000 FEET, THEN (N 40 °W) APPROXIMATELY 3,500 FEET TO A POINT 200 FEET SOUTH OF BIG SAVAGE MOUNTAIN HIKING TRAIL, THEN IN A NORTHEASTERLY DIRECTION ALONG THE EASTERN SLOPES OF BIG SAVAGE MOUNTAIN 200 FEET SOUTH OF AND PARALLEL TO THE BIG SAVAGE MOUNTAIN HIKING TRAIL UNTIL IT INTERSECTS WITH HIGH ROCK TOWER ROAD. THEN WEST ALONG THE HIGH ROCK TOWER ROAD TO A LINE 50 FEET FROM HIGH ROCK FIRE TOWER THEN CIRCLING THE TOWER COUNTERCLOCKWISE TO THE SOUTH NO CLOSER THAN 50 FEET TO THE TOWER TO A POINT DUE WEST OF THE TOWER, THEN ~~[[NORTHEAST]]~~ NORTHWEST DIRECTLY DOWN SLOPE TO THE STATE FOREST BOUNDARY LINE AND CONTINUING ALONG THE BOUNDARY LINE SOUTHWEST, PASSING SOUTH AROUND RHODES HILL, TURNING NORTH AND NORTHEAST UNTIL THE PROPERTY LINE INTERSECTS WITH SAW MILL HOLLOW TRAIL, THEN 200 FEET NORTH OF AND PARALLEL TO SAW MILL HOLLOW RUN UNTIL IT INTERSECTS WITH SAVAGE RIVER, THEN SOUTHWEST ALONG THE EAST BANK OF SAVAGE RIVER TO THE LAKE AND THEN SOUTH ALONG THE LAKE SHORE RETURNING TO THE WHITE WATER PRIMITIVE CAMPING AREA.

BEGINNING AT THE INTERSECTION OF SOLOMON RUN AND MONROE RUN AND PROCEEDING COUNTERCLOCKWISE (N20°W) TO THE RIDGELINE OF MIDDLE RIDGE, THEN UP MIDDLE RIDGE TO THE INTERSECTION WITH THE SOUTHERNMOST CORNER OF A PRIVATE INHOLDING, CONTINUE NORTHWESTERLY ALONG THE SOUTHERN BOUNDARY OF SEVERAL PRIVATE LANDS TO THE WESTERNMOST CORNER OF THE PRIVATE LANDS, THEN EXTENDING THE LINE NORTHWESTERLY TO ITS INTERSECTION WITH NEW GERMANY ROAD, IN SUCH A MANNER SO AS TO INCLUDE ALL OF MONROE RUN ROAD IN THE WILDLAND, THEREBY CLOSING IT TO UNAUTHORIZED MOTOR VEHICLES, THEN SOUTHWEST ALONG NEW GERMANY ROAD TO ITS INTERSECTION WITH BLACKHAWK SCHOOL ROAD THEN SOUTHEAST ALONG BLACKHAWK SCHOOL ROAD TO ITS INTERSECTION WITH DRY RUN ROAD AND THEN FOLLOWING THE STATE FOREST BOUNDARY LINE, OR THE NORTH SIDE OF DRY RUN ROAD, WHICHEVER IS FURTHER NORTH, IN AN EASTERLY DIRECTION AND TO THE NORTH SIDE OF SOLOMON RIDGE, TO SOLOMON RUN, THEN FOLLOWING SOLOMON RUN TO ITS CONFLUENCE WITH MONROE RUN AND THE BEGINNING OF THE TYPE I STATE WILDLAND.]]
