(B)

RECORDS OF THE COURT SHALL NOT BE OPEN TO PUBLIC INSPECTION OR THEIR CONTENTS DIVULGED TO ANYONE, EXCEPT FOR GOOD CAUSE SHOWN UPON ORDER OF A JUDGE EXERCISING JUVENILE COURT JURISDICTION.

(C)

THE COURT, ON ITS OWN MOTION OR FOR GOOD CAUSE SHOWN, MAY ORDER THAT JUVENILE COURT RECORDS BE SEALED AND THAT IN ANY EVENT THE JUVENILE RECORDS SHALL BE SEALED AFTER THE CHILD INVOLVED HAS REACHED 21 YEARS OF AGE. 11

(A) CONFIDENTIALITY OF POLICE RECORDS

POLICE RECORDS CONCERNING A CHILD ARE CONFIDENTIAL AND SHALL BE MAINTAINED SEPARATE FROM THOSE OF ADULTS. THEIR CONTENTS SHALL NOT BE DIVULGED, BY SUBPOENA OR OTHERWISE, EXCEPT UPON ORDER ISSUED BY A JUDGE EXERCISING JUVENILE COURT JURISDICTION IN MONTGOMERY COUNTY UPON GOOD CAUSE SHOWN; PROVIDED, HOWEVER, THAT NOTHING HEREIN SHALL BE DEEMED TO PROHIBIT ACCESS TO AND CONFIDENTIAL USE OF SUCH RECORDS IN THE INVESTIGATION AND PROSECUTION OF THE CHILD TO WHOM THE RECORDS RELATE BY AND AMONG LAW ENFORCEMENT AGENCIES AND THE STATE DEPARTMENT OF JUVENILE SERVICES.

(B) CONFIDENTIALITY OF JUVENILE COURT RECORDS

THE JUVENILE COURT RECORDS PERTAINING TO ANY CHILD ARE CONFIDENTIAL. AND THEIR CONTENTS SHALL NOT BE DIVULGED, BY SUBPOENA OR OTHERWISE, EXCEPT UPON ORDER ISSUED BY A JUDGE EXERCISING JUVENILE COURT JURISDICTION IN MONTGOMERY COUNTY UPON GOOD CAUSE SHOWN; PROVIDED, HOWEVER, THAT NOTHING IN THIS SUBSECTION SHALL BE DEEMED TO PROHIBIT ACCESS TO AND USE OF THE COURT RECORD OF A CHILD, IN A JUVENILE COURT PROCEEDING INVOLVING THAT CHILD, BY PERSONNEL OF THE COURT, THE STATE'S ATTORNEY, THE COUNTY ATTORNEY, COUNSEL FOR THE CHILD, THE DEPARTMENT OF JUVENILE SERVICES, AND PROBATION OFFICERS.

(C) THE SEALING OF JUVENILE COURT RECORDS

A JUDGE EXERCISING JUVENILE COURT JURISDICTION IN MONTGOMERY COUNTY, SUA SPONTE OR UPON PETITION, AND FOR GOOD CAUSE SHOWN, MAY ORDER THE COURT RECORDS OF A CHILD TO BE SEALED, SUCH RECORDS SHALL BE SEALED WHEN THE CHILD HAS REACHED TWENTY-ONE (21) YEARS OF AGE, UPON SEALING, THE COURT RECORDS OF A CHILD SHALL NOT BE OPENED, FOR ANY PURPOSE, EXCEPT UPON ORDER ISSUED BY A JUDGE EXERCISING JUVENILE COURT JURISDICTION IN MONTGOMERY COUNTY UPON GOOD CAUSE SHOWN.
