NO PERSON MAY WILLFULLY WITH FORCE PREVENT OR ATTEMPT TO PREVENT ANY MEMBER, OFFICER, OR EMPLOYEE OF THE LEGISLATURE, EITHER HOUSE THEREOF, OR ANY COMMITTEE OF THE LEGISLATURE OR EITHER HOUSE THEREOF, FROM PERFORMING ANY OF HIS OFFICIAL FUNCTIONS, POWERS, OR DUTIES.

94. DESTRUCTION OF DOCUMENTS.

NO PERSON MAY WILLFULLY AND WITHOUT LEGAL AUTHORITY TAKE, OBTAIN, WITHHOLD, DESTROY, DEFACE, OR ALTER ANY OFFICIAL DOCUMENT OR RECORD OF THE LEGISLATURE, EITHER HOUSE THEREOF, OR ANY LEGISLATIVE COMMITTEE.

95. DESTRUCTION OF OTHER PROPERTY.

NO PERSON, WITHOUT LEGAL AUTHORITY, MAY TAKE, OBTAIN, WITHHOLD, POSSESS, DESTROY OR DEFACE ANY REAL OR PERSONAL PROPERTY OWNED OR USED BY THE LEGISLATURE, EITHER HOUSE THEREOF, OR ANY LEGISLATIVE COMMITTEE.

NO PERSON MAY WILLFULLY ENTER OR REMAIN WITHIN OR UPON ANY PART OF THE CHAMBER, GALLERIES, OR OFFICES OF THE LEGISLATURE, OR EITHER HOUSE THEREOF, OR WITHIN OR UPON ANY OFFICE OR RESIDENCE OF ANY MEMBER OF THE LEGISLATURE OR WITHIN OR UPON ANY ROOM OR BUILDING IN WHICH A LEGISLATIVE HEARING OR MEETING IS BEING CONDUCTED, WITHOUT PROPER AUTHORIZATION. NOTHING CONTAINED HEREIN PROHIBITS ANY MEMBER, OFFICER, OR EMPLOYEE OF THE LEGISLATURE, EITHER HOUSE THEREOF, OR ANY LEGISLATIVE COMMITTEE FROM PERFORMING ANY ACT IN THE LAWFUL DISCHARGE OF HIS OFFICIAL DUTIES.]]

NO PERSON MAY WILLFULLY PICKET INSIDE ANY BUILDING IN WHICH THE CHAMBER OF EITHER HOUSE OF THE STATE LEGISLATURE IS LOCATED OR IN WHICH THE OFFICIAL OFFICE OF ANY MEMBER OF THE LEGISLATURE OR THE OFFICE OF ANY COMMITTEE OF THE LEGISLATURE OR EITHER HOUSE THEREOF IS LOCATED.

NO PERSON MAY WILLFULLY BRING A FIREARM OR ANY EXPLOSIVE OR INCENDIARY DEVICE INTO, OR POSSESS A FIREARM OR ANY EXPLOSIVE OR INCENDIARY DEVICE WITHIN ANY BUILDING IN WHICH THE CHAMBER OF EITHER HOUSE OF
