- (4) SUBSEQUENT TO THE ISSUANCE OF A LICENSE THERE SHALL BE NO CHANGE IN THE LOCATION OF FEEDING ZONES OR SHOOTING BLINDS OR STANDS WITHOUT APPROVAL OF THE [[ADMINISTRATION]] DEPARTMENT.
- (5) ALL CLUB MEMBERS, GUESTS, AGENTS AND PERMITTEES OF THE APPLICANT SHALL BE PRESUMED TO HAVE KNOWLEDGE OF THE LOCATIONS OF THE FEEDING ZONES AND THE AREAS WHERE SHOOTING IS PROHIBITED.
- (6) FEEDING SHALL COMMENCE ON AND CONTINUE THROUGH SUCH DATES AS THE [[DIRECTOR]] SECRETARY SHALL DESIGNATE. PRIOR TO THE OPENING OF THE MIGRATORY WATERFOWL SEASONS FEEDING MAY BE DONE ANYWHERE ON THE LICENSED AREA, PROVIDED THAT ALL FOOD PUT OUT IN PLACES OTHER THAN THE DESIGNATED FEEDING ZONES SHALL HAVE BEEN CONSUMED OR REMOVED AT LEAST 10 DAYS PRIOR TO THE OPENING DATE OF THE SEASON. THEREAFTER, NO FEED SHALL BE PLACED ANYWHERE EXCEPT IN THE DESIGNATED FEEDING ZONES. AS USED IN THE REGULATIONS FEEDING SHALL NOT BE CONSTRUED AS INCLUDING SALT BLOCKS, PROPERLY SHOCKED CORN, STANDING CROPS (INCLUDING ACQUATICS), FLOODED STANDING CROPS, FLOODED HARVESTED CROPLANDS, OR GRAINS FOUND SCATTERED SOLELY AS A RESULT OF NORMAL AGRICULTURAL PRACTICES.
- (7) NO PERSON SHALL SHOOT OR HUNT, OR ATTEMPT TO DO SO. WITHIN [[200]] 400 YARDS OF ANY LICENSED FEEDING ZONE; PROVIDED, HOWEVER, THE HUNTER OR HIS AGENT, MAY RETRIEVE ANY DEAD OR CRIPPLED BIRD WITHIN THAT AREA IN WHATEVER MANNER IS LAWFUL UNDER THE APPROPRIATE REGULATIONS. NO PERSON STATE FEDERAL AND OTHERWISE SHOOT OR HUNT, OR ATTEMPT TO DO SO, FROM ANY SITE OR LOCATION IN THE LICENSED AREA EXCEPT THE LICENSED SHOOTING BLINDS AND STANDS. IN ADDITION TO ANY OTHER ACTION BY THE [[ADMINISTRATION]] DEPARTMENT, VIOLATION OF THIS SECTION BY THE LICENSEE, HIS AGENTS, CLUB MEMBERS, GUESTS, OR PERMITTEES SHALL BE GROUNDS FOR IMMEDIATE REVOCATION OF THE FEEDING LICENSE.
- (8) BLINDS LOCATED WITHIN 200 YARDS OF ANY LICENSED FEEDING ZONE SHALL BE RENDERED INCAPABLE OF USE.
- (9) WITHIN 15 DAYS AFTER THE DESIGNATED CLOSING DATE FOR PUTTING OUT FEED THE LICENSEE SHALL SUBMIT A WRITTEN REPORT TO THE [[ADMINISTRATION]] DEPARTMENT GIVING THE APPROXIMATE AMOUNTS AND TYPES DISTRIBUTED AND INDICATING BETWEEN WHAT DATES THE FEED WAS DISTRIBUTED.

(1) LICENSED AREAS, NOT INCLUDING ANY HOUSES OR OTHER CLOSED-IN STRUCTURES, SHALL BE OPEN TO INSPECTION AT ALL TIMES BY AN AUTHORIZED REPRESENTATIVE OF THE [IADMINISTRATION]] DEPARTMENT AND/OR THE U.S. FISH AND WILDLIFE SERVICE.
