(b) The Department of Natural Resources, if it believes the institution of suit to be advisable, shall turn over to the Attorney General all pertinent information and data. The Attorney General thereupon shall file suit against the person or persons causing the condition complained of, who shall be jointly and severally liable for the reasonable cost of rehabilitation and restoration of the resources damaged and the cost of eliminating the condition causing the damage, INCLUDING THE ENVIRONMENTAL MONETARY VALUE OF SUCH RESOURCES AS ESTABLISHED BY REGULATION.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 1973.

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That Section 31(a) of Article 59 of the Annotated Code of Maryland (1971 Replacement Volume and 1972 Supplement), title "Mental Hygiene," subtitle "Facilities," be and it is hereby repealed and re-enacted, with amendments, to read as follows:

(a) The following existing facilities shall be maintained as public facilities under the general jurisdiction of the Commissioner.
