- (i) The State's Attorney of Wicomico County lor of Harford County, as the case may be, I may petition the Circuit Court to enjoin any violation of this section.
- (j) Any person, firm, or corporation violating the provisions of this section is guilty of a misdemeanor and, upon conviction, is subject to the following penalties. The first conviction is punishable by a fine not to exceed five hundred dollars (\$500.00), a second conviction is punishable by a fine not to exceed one thousand dollars (\$1,000.00), for each employee caused, directed, permitted or authorized to work in violation of this section. Nothing contained herein shall be construed to permit any fine upon any employee or agent who has been caused or directed by his employer to violate the provisions of this section.
