- 14(g)(1) There shall be established in Harford County a "Class B-1 restaurant license" which may be issued by the liquor control board to bona fide restaurants. The cost of said license shall be one hundred and fifty dollars (\$150.00) and the licensee shall comply with the food sale requirements set forth in \$ 2(p) of this article. Any restaurant described herein shall be entitled to the issuance of a special Sunday Hon-off sale only 11 ON AND OFF SALE license upon payment of an additional fee of seventy-five dollars (\$75.00).
- (g)(2) There shall be created in Harford County a "Class B-2 restaurant license," which may be issued by the liquor control board to a licensee who has been operating his business establishment for one year prior to the application for Isaid I THE license and who is, in the judgment of Isaid I THE board, equipped and stocked for the continued regular sale of food to customers and guests. The cost of Isaid I THE license shall be two hundred and twenty-five dollars (\$225.00) and the licensee need not comply with the food sale requirement set forth in \$2(p) of this article. ANY RESTAURANT DESCRIBED HEREIN SHALL BE ENTITLED TO THE ISSUANCE OF A SPECIAL SUNDAY I ION-SALE II ON AND OFF SALE I IONLY II LICENSE UPON PAYMENT OF AN ADDITIONAL FEE OF SEVENTY-FIVE DOLLARS (\$75.00).

- II(f-2)11 (f-2)(1) In Harford County the annual fee for such a license shall be sixteen hundred dollars (\$1,600.00) for a restaurant and twenty-one hundred dollars (\$2,100.00) for a hotel; and a restaurant or hotel as defined below shall be entitled to the issuance of special Sunday license upon payment of an additional fee of three hundred AND SEVENTY-FIVE [I(\$300.00)]] (\$375.00). THIS LICENSE PERMITS THE SALE OF LIQUOR FOR CONSUMPTION INSIDE THE PREMISES ONLY. IN ADDITION, BEER AND LIGHT WINE MAY BE SOLD FOR CONSUMPTION ON AND OFF SALE PURSUANT TO SECTION 14(G) OF THIS ARTICLE.
- (2) Such a license may be issued in Harford County to a bona fide hotel which (i) is an establishment for the accommodation of the public, providing services ordinarily found in hotels, (ii) is equipped with no fewer than 25 rooms, a lobby with a registration and mail desk and seating facilities, and a dining room which serves full-course meals at least twice daily. This license in a hotel shall permit sale at bars or counters, but not LIQUOR for consumption off the premises. BEER AND LIGHT WINE MAY BE SOLD FOR CONSUMPTION ON AND OFF SALE PURSUANT TO SECTION 14(G) OF THIS ARTICLE.
- (3) Such a license may be issued in Harford County to a restaurant which meets the following requirements and conditions;
- (i) Serves full-course meals at least twice daily; (ii) has a regular seating capacity of tables, not including seats at bars or counters for sixty or more persons; (iii) has been in full-time operation as a restaurant for not less than [[[]]] [ISIX MONTHS]] immediately preceding the time the application is made for license [; I, PROVIDED HOWEVER, THAT THE [ISIX MONTH]] ONE YEAR TIME PERIOD REQUIREMENT DOES NOT APPLY TO A LICENSEE WHOSE BUSINESS HAS BEEN DISRUPTED OR INTERRUPTED AS A RESULT OF FIRE OR OTHER DISASTER; (iv) has had daily average receipts from the sale of food in excess of sales of alcoholic beverages during the [[[]]] twelve [[]]] [ISIX]] month period immediately preceding the application for license; (V) SHALL FILE A MONTHLY REPORT OF GROSS RECEIPTS FOR THE SALE OF FOOD AND ALCOHOLIC
