APPLYING FOR A NEW CERTIFICATE OF TITLE. THE LICENSED AUTO WRECKER SHALL EXECUTE AN ASSIGNMENT OF TITLE TO THE TRANSFEREE LICENSED AUTO WRECKER OR REGISTERED DEALER ON FORMS PRESCRIBED BY THE ADMINISTRATION. THE ASSIGNMENT SHALL INCLUDE A STATEMENT CERTIFYING ALL LIENS AND ENCUMBRANCES ON THE VEHICLE.

- (A) ANY AUTO WRECKER OR SCRAP PROCESSOR OWNING A VEHICLE WHICH IS MAINLY USED IN HIS BUSINESS AND WHICH IS OTHERWISE REQUIRED TO BE REGISTERED UNDER THIS SUBTITLE MAY OPERATE OR MOVE IT UPON THE HIGHWAYS WITHOUT REGISTERING THE VEHICLE UPON CONDITION THAT THE VEHICLE DISPLAYS THEREON, IN THE MANNER PRESCRIBED IN SECTION 3-411, ONE (1) AUTO WRECKER-SCRAP PROCESSOR REGISTRATION PLATE ISSUED TO THE OWNER BY THE ADMINISTRATION.
- (B) A REGISTERED AUTO WRECKER OR SCRAP PROCESSOR MAY USE HIS REGISTRATION PLATES ON VEHICLES IN HIS POSSESSION BUT NOT OWNED BY HIM IF HE HAS THE CONSENT OF THE OWNER TO THIS USE.
- (C) AUTO WRECKER-SCRAP PROCESSOR PLATES SHALL NOT BE USED AFTER NOTIFICATION BY THE ADMINISTRATION THAT THEY ARE FORFEITED, BECAUSE OF VIOLATION OF THE PROVISIONS OF THIS ARTICLE.
- (D) IF ANY LICENSE ISSUED TO AN AUTO WRECKER OR SCRAP PROCESSOR UNDER SUBTITLE 5 IS SUSPENDED, CANCELLED OR REVOKED, ALL AUTO WRECKER-SCRAP PROCESSOR REGISTRATION PLATES ISSUED TO AUTO WRECKERS OR SCRAP PROCESSORS SHALL BE INVALID AND NO AUTO WRECKER OR SCRAP PROCESSOR SHALL OPERATE OR MOVE OR PERMIT THE OPERATION OR MOVEMENT OF ANY VEHICLE UNDER THESE PLATES.

3-815.

- (A) EACH YEAR A FEE OF \$35.00 SHALL BE PAID FOR THE FIRST TWO REGISTRATION PLATES ISSUED TO AN AUTO WRECKER OR SCRAP PROCESSOR FOR USE ON USED VEHICLES; AND A FEE OF \$7.00 FOR EACH ADDITIONAL REGISTRATION PLATE ISSUED TO AN AUTO WRECKER OR SCRAP PROCESSOR FOR THIS PURPOSE.
- (B) THESE REGISTRATION PLATES SHALL BE INTERCHANGEABLE AMONG THE VEHICLES OWNED OR USED BY AN AUTO WRECKER OR SCRAP PROCESSOR DURING THE CURRENT YEAR IN WHICH ISSUED BUT ONLY ON VEHICLES WHICH MAY LAWFULLY BE OPERATED UNDER THESE PLATES, AS PROVIDED FOR IN SECTION 3-601.2 OF THIS SUBTITLE.

The Administration shall pay a fee of Itwelve dollars (\$12.00) SIXTEEN DOLLARS (\$16.00) for each vehicle which has been completely destroyed upon presentation by the scrap processor to the Administration of the certificate of title or other acceptable evidence of ownership for a vehicle formerly titled in this State, the manufacturer's serial or identification number plate, satisfactory proof
