

(B) INVESTIGATING COMMITTEE. THE HOUSE OF DELEGATES OR THE SENATE, AFTER RECEIVING THE REPORT, MAY ESTABLISH BY RESOLUTION AN INVESTIGATING COMMITTEE UNDER THE SUBTITLE "LEGISLATIVE INVESTIGATING COMMITTEES: CODE OF FAIR PROCEDURES" IN ARTICLE 40 OF THE ANNOTATED CODE OF MARYLAND; and be it further

RESOLVED, That the rules above listed for adoption in this Joint Resolution shall take effect simultaneously on Rules of both the Senate and of the House of Delegates of Maryland immediately upon passage by a separate constitutional majority in such House of the General Assembly of Maryland; and be it further

RESOLVED, That upon the final and official adoption of this Joint Resolution by both Houses of the General Assembly of Maryland, the Chairman of the Committee on Legislative Ethics is requested to send a copy of this Joint Resolution to each member of the General Assembly of Maryland and generally to circulate copies of this Joint Resolution among the news media and other interested persons and agencies in the State of Maryland.
